NOROVIRUS

These are a group of viruses that attack the intestinal tract and are highly contagious. They are a leading cause of food borne illness, most often in the food service industry from infected workers not wearing gloves. Noroviruses are very common in closed, crowded environments such as daycare centers, nursing homes and residential care facilities, hospitals, schools and cruise ships. Noroviruses can stay on surfaces and objects for days to weeks, and can withstand hot and cold temperatures and many disinfectants,

Sources of infection include: Ingesting tiny particles of feces or vomit from an infected person; direct contact with an infected person through the sharing of food or utensils; touching contaminated surfaces and putting fingers in the mouth; eating or drinking contaminated foods or liquids; septic tank leaks into the well. Water treatments are ineffective. Outbreaks are most common from November to April.

Symptoms: Nausea, vomiting and diarrhea (that can result in dehydration), abdominal pain, headache, fever, body aches. Symptoms develop 12 - 48 hours after exposure, with recovery in about 1 - 3 days. A person can spread the virus up to 2 weeks or more after feeling better.

Treatment: There is no specific treatment for noroviruses. Drink plenty of fluids to prevent dehydration. Avoid consuming dairy products, fatty or spicy foods. Anti -nausea medications may be used. Antibiotics are not given to treat a norovirus. Avoid travel until 2-3 days after symptoms are gone.

Public Policy

The Wisconsin Department of Health Services (DHS) announced that for fiscal year 2023, it will cover an average of about 90% of nursing homes' costs providing care for residents enrolled in the Medicaid program. Calling the funding increase historic, nursing home advocates noted that in addition to the increase for direct services, there is a large funding increase for support services, which includes a broad array of costs such as those related to administrative services and other operational expenses. The nursing home representatives said those increases consider the diverse needs of providers across the state. WHA President and CEO Eric Borgerding noted, "On any given day, from 10 to 20% of the staffed inpatient beds in many hospitals are occupied by patients who are ready for discharge but waiting for a nursing home placement. Those are staffed hospital beds that are not available for patients with acute, hospital-level care needs." Borgerding emphasized, "Communities, hospital patients, and their families need access to quality skilled nursing facility care so we, of course, support efforts that help ensure that access, including this additional funding. But more than 2,000 nursing home beds have closed since the beginning of the pandemic even with previous funding and support increases. We believe that one of the measurable purposes for this second historic state funding increase in less than two years must be that expected capacity is there when patients, including those covered by Medicaid and Medicare, need it most." This is particularly interesting due to the ongoing discussion the Washington County Board has regarding the future of Samaritan.

WHA President and CEO Eric Borgerding participated in a Wisconsin Health News panel discussion held virtually on Nov. 29. Borgerding and fellow panelists representing doctors, nurses, health plans and nursing homes discussed the impact of the elections on health care-related issues, as well as previewed top priorities for the upcoming legislative session. While the election results did not change the balance of power in Madison, like every election there will be many new lawmakers and staff. Panelists shared their top health care priorities for the upcoming legislative session. For hospitals, Borgerding emphasized reimbursement as an ongoing budget issue. Wisconsin's Legislature has prioritized funding of the Medicaid program over the years, and as s a non-Medicaid expansion state, the legislature has not abandoned, in any way, funding that program while at the same time rejecting Medicaid expansion.

Gentle reminder, registration for Advocacy Day will begin in January. This year's event is being planned as an "in person" event on April 19th in Madison. Please consider joining H.E.A.T. This is an awesome opportunity for you, as a hospital volunteer and on a personal level, to be aware of legislative and Wisconsin Hospital Association changes and updates for the continuation of positives for our Wisconsin healthcare----your "voice" does MATTER.

On a personal note, beginning January 1st I will assume the duties as Partners of WHA State President.....many challenges and changes ahead and I promise to be ever mindful of what is best for the benefit of the entire Partners Organization. I ask for your continued support as my new journey begins, I so value your friendship and proud of our Awesomeness as Partner Volunteers of Froedtert West Bend Hospital.
