- Fiduciary duties: making complex decisions to eliminate outdated expenses, developing credit card access as a payment option for convention purposes, and raising dues (on the overwhelming advice from membership) to allow a larger return to districts.
- District merger: successful discussions with the ٠ Northwestern, West Central and North Central districts to merge into the Northern District, thus allowing for better management of resources and allowing their volunteer base to remain valuable participants within our organization. # **Community Health Education Report**

The Impact of Loneliness on Physical and Mental Health

Loneliness is a growing problem with substantial physical and mental health risks. Research shows loneliness and social isolation may be as detrimental to your health as obesity and smoking, and significantly impacts mental health.

Persistent loneliness is associated with higher rates of heart disease, depression, anxiety, and dementia. While it impacts people of all ages and backgrounds, some people are more at risk than others. Much of the research has focused on older adults; however, recent surveys show loneliness is especially high among teens and young adults. Loneliness is a common experience with 80% of the population below 18 years of age and 40% of the population above 65 years of

age reporting loneliness at some time in their life.

People with poor physical health, those with pre-existing mental health concerns, and people who live alone are more likely to be lonely. Life transitions and disruptions, such as going away to college, moving, becoming a parent, retiring, or losing a partner can also increase the risk of loneliness and social isolation.

There are three types of loneliness: **Situational loneliness** is caused by environmental factors such as unpleasant experiences, inter-personal conflicts, accidents, and disasters. **Developmental loneliness** may be caused by perceived personal inadequacies, developmental deficits, significant separations, poverty, and physical or psychological deficits. **Internal loneliness** may be caused by personality factors such as low self-esteem, guilt feelings, and poor coping skills.

According to the American Psychiatric Association, a variety of approaches can be used to address loneliness, including increasing availability and access to community activities. Health promotion efforts can raise awareness about the importance of social connection and emphasize the health benefits of maintaining social relationships.

Australia and the United Kingdom have been active in addressing the problem of loneliness. In Australia, community volunteers visit isolated older adults as part of a National Community Visitors Program. The Campaign to End Loneliness in the United Kingdom provides public awareness and health promotions, supports individuals and sponsors with specific-themed social activities and provides transportation for participants. In the United States, the Connect2Affect Program is a collaborative effort between AARP, the Gerontological Society of America, Give an Hour, the National Association of Area Agencies on Aging, and the UnitedHealth Group to address the issue of social isolation among older adults. It offers an online assessment and links to resources, information, and research.

The recognition of loneliness as a significant health risk factor is relatively new. In *"Loneliness: Science and Practice"* by Phaedra Bell, PhD and Brian Lawlor, MD, they suggest screening patients for loneliness and other aspects of social connection at each doctor visit is just as important as measuring their blood pressure and other vital signs.

Let's make a concerted effort to reach out to friends, neighbors and co-workers with a smile, a visit, a phone call just to say "Hi" and see how they are doing. It might be the highlight of their day.

# **Public Policy Education Report**

## The Value of Healthcare Volunteers, The Healthcare Workforce and The Continuity of Care Dilemma Addressed by CEO Panelists

Partners was fortunate to have a panel of exceptional CEOs at our 2024 convention. They came to us from hospitals where "Healthy Volunteer Partners Programs" are at work. WHA Director of Federal and State Relations Jon Hoelter served as moderator, directing the conversation toward those questions provided by our membership in advance. The panel included the following hospital CEOs: David Hartberg, Vernon Memorial Healthcare, Viroqua; John Russell, Prairie Ridge Health, Columbus; and Marc Augsburger, Edgerton Hospital & Health Services, Edgerton. Topics presented for discussion included the healthcare workforce, the continuing impact on hospitals post-COVID; and the changing role of volunteer programs.

### **Encouraging Student Interest in Healthcare**

Each of the participating hospitals is just above the critical access (25 beds) category and all are near or fully staffed. Each CEO shared efforts they have employed to create interest in young adults at area schools. The effort is to "showcase" healthcare professions to fill voids due to retirements or for those who have left the healthcare profession. Technology offers an area of interest for students considering healthcare. Scholarships are available for students to engage in healthcare studies. Each hospital participates in that effort. Staff retention is a critical component, particularly post-pandemic as some healthcare staff left for "greener pastures." Hospitals offer a Healthcare Academy for high school students to learn more about speech therapy specialists and other hands-on lab technology-type experiences. School based "Career Days" are a further activity to engage students in earning scholarships provided for studies in healthcare.

## **Prior Authorizations**

Prior authorizations are critical to timely and appropriate healthcare. There has been a growing resistance by healthcare plans and providers to grant those authorizations. Recent studies have shown that Medicare Advantage plans initially deny prior authorization by up to 90%. The result is time delays and denial of medications and/or procedures. Ultimately 80% are approved but delays interject significant medical risk to patients who are waiting for "appropriate medical care." A study by UW Health found that over \$18 million payroll dollars have been devoted to this problem. Unfortunately, some healthcare organizations gain financially from this delayed practice, one up to \$82 million dollars in corporate income.

## Post-Acute Care/Continuity of Care Dilemma

This topic is a result of the COVID pandemic and the closure of many nursing homes during that period, causing shortages in staff. To date, it appears little improvement has been made and as a result, many patients stay in the hospital longer. Hospitals continue to incur cost without reimbursement.

## **Changing Nature of Healthcare Providers**

There is a growing contingent of hospitals created by outside investors who are in the game to earn returns of more than 20% on their investment. A normal return for not-for-profit hospitals (NFP) is from 1-3%, while new "Private Equity Hospitals" earn upwards of a 20-30% return. All of this is occurring in a climate where earnings in safety net hospitals like HSHS Sacred Heart-Eau Claire and HSHS St. Joseph's-Chippewa Falls were negative 45%! How does this happen, you ask? Private equity hospitals do not serve Medicare, Medicaid, or indigent care patients. This practice creates significant financial stress on our "traditional" hospitals.

## What do Healthcare Volunteers Bring to Their Community Hospitals?

Post-hospital patient questionnaires reveal the value of services and attention provided by hospital volunteers. As one CEO stated, volunteers do much to add value and allow staff professionals to "stay in their lane" to do their job. Former employees are great volunteers and carry forward the value brought by their prior efforts. One hospital makes special non-nurse awards to volunteers. The volunteers walk in through the hospital doors with a voice of advocacy. One hospital devotes volunteer efforts toward follow-up of patient discharge questionnaires. The result is an opportunity to improve initial patient contact.

The process to identify participants for the CEO panel, those who represent an active Partners volunteer group, requires considerable effort from the convention committee. Further, the panel moderator devotes time

# **Strategic Planning Committee Report**

Strategic planning goals for 2023/2024 included:

- 1. Reviewing districts for potential re-structuring/re-balancing. Creating a process for districts to merge if needed.
- 2. Reviewing the convention planning process and structure.
- 3. Reviewing membership structure and working with the by-laws committee to propose by-laws changes to accommodate individual members.

### Goal #1

- Discussions involving district restructuring/rebalancing resulted in the merger of the Northwestern, West Central, and North Central districts into one district known as the **Northern District**.
- A procedure for district restructuring was developed and will be filed.

## Goal #2

- The strategic planning committee put together a survey following the 2023 convention. The survey was posted on the partners website for two months and was sent to more than 100 members. Feedback was received from more than 100 respondents. The committee reviewed the feedback and made recommendations to the leadership board, which included:
  - Making convention easy to get to keeping it centrally located.
  - Having a different length of convention every other year.
  - Keeping speakers focused on healthcare and what volunteers provide.
  - Using previous WAVE award winners to present workshops.

\*\*\*Due to decreased Partners membership and decreased attendance at the Convention, further changes are likely. \*\*\*

### Goal #3

• The strategic planning committee, along with the by-laws committee wrote modifications to the by-laws allowing for individual memberships. These were published in two newsletters prior to the 2024 Fall Convention. The changes to allow individual memberships to the Partners of WHA were approved during the Partners' Annual Business Meeting on Wednesday, October 2nd, 2024.
