ASPIRUS - STANLEY HOSPITAL

At this time our name has not been changed on our corporation and Aspirus wants us to join with them, thus dropping our corporation. Since it is a legal corporation and in the past the hospital has taken care of legal matters, we aren't sure if we can legally change our name to Partners with Aspirus Stanley Hospital. Their legal department doesn't want to do this change for us. So as far as the District and State goes, we should probably leave our name as Partners with OLVH.

We met with our new CAO Rob Holcomb to get information on how we would move forward if we were to go with Aspirus. We are still gathering information so that we can make a wise decision. We seem to keep coming up with questions that we would like answers to.

However, in spite of the hospital changing over to Aspirus, we have still accomplished a couple of things so far this year. Since the December tornado was unusual and with all the damage to homes and businesses, we decided to donate money to the tornado fund that was set up at one of the local banks. We donated money to the hospital to purchase equipment they needed to be able to better help patients, a vital machine and a recliner for knee and hip replacements patients. Aspirus Stanley Hospital began doing knee and hip replacements in November 2021.

We awarded three \$500 high school scholarships in May. We normally award two high school students and one employee but (Aspirus-Stanley Hospital Continued)since we did not have any employee applicants, we decided to give three high school scholarships.

Public Policy Education (PPE) Report

Wisconsin Hospitals Commit More Resources to Communities, Face Larger Medicare Losses

Hospitals across the nation committed 13.9% of their overall expenses to community benefit, equating to \$110.9 billion each year, according to the <u>American Hospital Association</u> (AHA) and an <u>Ernst & Young analysis</u> of non-profit hospital expenses.

Annual community benefits made by Wisconsin hospitals, when calculated in the same manner as the AHA report, result in 21.2% of all expenses—largely driven by significant losses from Medicare and Medicaid, accounting for 78.8% of all community benefits. In total, Wisconsin hospitals provide \$4.9 billion in benefits to Wisconsin communities as a commitment they make for being a non-profit, tax-exempt organization.

This data also shows how poorly Medicare reimburses Wisconsin hospitals. According to AHA's data, hospitals nationally experience a 3.1% shortfall in Medicare reimbursement as a percentage of their overall expenses. In Wisconsin, Medicare losses to hospitals account for a whopping 12% of their expenses. Medicare reimburses Wisconsin hospitals only 73% of their costs, while Medicare reimbursement to the rest of the country amounts to 84% of cost. Similarly, Wisconsin's Medicaid program reimburses hospitals only 66% of cost, while the national average for state Medicaid reimbursement is equivalent to 88% of cost. This is important to understand because for the vast majority of Wisconsin hospitals, Medicare and Medicaid patients make up more than half of their overall business.

Community Heath Education (CHE) Report

Monkeypox is a rare viral infection similar to Smallpox that occurs mostly in regions of Africa. It gets its name from being first identified in infected monkeys (thought to be infected by African rodents). However, some US cases in the past have been a result of close contact with infected prairie dogs. Monkeypox is spread person to person through prolonged face-to-face contact whereby large drop-lets can enter the respiratory tract and mucous membranes such as the eyes, nose, mouth. It can also spread when there is contact with the lesions, body fluids, and contaminated bedding and clothing. Animal to human transmission occurs from contact with the blood, body fluids, and lesions of the infected animals.

Currently, there is 1 case confirmed in the state of Massachusetts, and suspected cases in New York, Florida, Utah, and Washington State. Concerning is that Monkeypox could become a worldwide outbreak with cases seen in Europe, Canada, and Australia.

Symptoms include fever, chills, aches, fatigue, swollen lymph nodes, and blister like lesions. The lesions become pustules and drain, crusting over, then healing. Monkeypox is contagious until the lesions are scabbed. The recovery period from the illness is usually 2-4 weeks.

There is no specific treatment for Monkeypox. Care should focus on lessening the symptoms and preventing long-term effects. Antiviral medication and Immune Globulin may be used in severe cases. Complications may include secondary infections such as pneumonia, sepsis, encephalitis, and infection of the cornea of the eye (can lead to blindness). In the past, individuals who received the smallpox vaccine were also protected from Monkeypox. A newer vaccine is available for high-risk individuals, such as healthcare workers, that is in the process of being released from the US government stockpile.
