from the presentation are the following:

- Honor Points are reinstated for calendar year 2021.
 Distribution during Spring Tour 2022.
- The minimum 40 points requirement remains unchanged. Dues being suspended for 2021 will NOT penalize organization's ability to receive Honor Point recognition.
- Two new categories have been added with point values of 2 points each. NEW: 2 points for at least one general membership meeting and 2 points for a member serving in a leadership role at the district or state level. Must be serving in the position during the calendar year of tallying Honor Points. To include past presidents, all state boards of directors, and district level positions. This is a correction from the spring meetings, I incorrectly stated only elected leadership roles were eligible for the 2 points. PLEASE NOTE THE CORRECTIONED POSITION INCLUSIONS.
- Additional bonus point (1) will be given for the minimum of three newsletters. Raises point value to 4
- The new form may be found on the Partners Website, <u>PartnersofWHA.org</u> under the "forms" tab.

Congratulations to the newly installed district chairs: Lois Kreeger (Lakes); Lyn Krohn (North Central); Beth Burnham and Beverly Lazar, Co-Chairs, (Northwestern); Jane Henderson (Southeastern); Barbara Lauersdorf (Southern); Betty Oddo (West Central); and Donna Nelson (Western). I look forward to working with this group of leaders and know they will serve their districts well.

I believe, at this writing, many are beginning to return to their volunteer duties. A few years ago, I had the opportunity to attend the American Hospital Association (AHA) meeting in Washington, D.C. Volunteer



leaders from several states were also in attendance. While networking with these individuals, it became very clear that hospital volunteer organizations, (be they large or small, auxilians or volunteers, urban or rural) were facing many of the same concerns and challenges. These discussions led to Wisconsin, North Dakota, Minnesota, and Iowa forming a regional networking group. Unfortunately, COVID-19 intervened before we were able to get the group up and running.

In April 2021, representatives from the four states met via a conference call and talked about goals and objectives. Committee members agreed that connecting with others, sharing information, and establishing a mutually beneficial relationship would be of value to members in all states. Public Policy Education Report

Without question, there has been a lot to be said about the costs and availability of prescription drugs important for the aging population, especially those dependent upon health care services provided by Medicare.

The intention of the 340B program established in 1992 put forth a requirement that drug companies extend discounts of from 20-50% to hospitals and clinics serving low-income Medicare patients. An October 2020 WHA newsletter reviewed actions taken by Health & Human Services to push back on drug manufacturers' intention to no longer honor their obligation to pass on discounts provided under the Program. A TOWNHALL article of February 27, 2021, noted a recent review by the Government Accountability Office found over half of 340B drug manufacturers offered no discounts

to their contract pharmacies. The article further stated, "preventing such blatant abuse of this health care safety net shouldn't be a partisan issue."

A key shortcoming of the 340B Program is that Health & Human Services has no negotiating position with drug manufactures under the Medicare prescription drug benefit.

In mid-2019, both Senate Bill 2543 and House Bill H.R. 3 sought action to lower drug costs, and H.R.3 specifically to establish Negotiation of Medicare drug prices. Neither passed approval by their respective counterpart!

The March 2021 American Hospital Association Fact Sheet acknowledges the success from AHA's recent law suit Senate Bill 773, to strengthen Health Resources and Services Administration's oversight of 340B drug pricing. March 23, 2021, the Subcommittee Hearing on Pharma Greed, chaired by Senator Bernie Sanders, introduced legislation to control the rising costs of prescription drugs. Three bills are a part to include: The Prescription Drug Relief Act, with the intent to peg the price of prescription drugs in the U.S. to the median price in Canada, the United Kingdom, France, Germany, and Japan; The Medicare Drug Price Negotiation Act, directing the Secretary of Health and Human Services to negotiate lower prices to prescription drugs under Medicare Part D; and The Affordable and Safe Prescription Drug Importation Act, to allow patients, pharmacists, and wholesalers to import safe, affordable medicine from Canada and other major countries.

Representative Lloyd Doggett (D-Texas), stated, "I am pleased to join Senator Sanders in his ongoing crusade against prescription price gouging by sponsoring the House companion to the Medicare Drug Price Negotiation Act, previously introduced by the late Elijah Cummings." The current Bill unequivocally repeals the prohibition for Medicare to negotiate pricing with big pharma.

Under the Prescription Drug Relief Act, the Secretary of Health and Human Services can ensure that Americans do not pay more for prescription drugs that the median price of the following countries of Canada, the United Kingdom, France, Germany, and Japan. If pharmaceutical manufacturers refuse to lower drugs prices to the median price of these five countries, the federal government would be required to approve cheaper generic versions of those drugs, regardless of any patents or market exclusivities that are in place.

Through WHA, our connection to advocacy for health care legislation, we encourage you to review and respond to timely Action Alerts received from HEAT. More to come on this subject, for sure!
